KILKENNY G.A.A. FIXTURES GAMES REGULATIONS 2021

The following regulations were passed by An Choiste Chontae Chill Chainnigh at a meeting on Monday 14th June 2021 and will operate for all games (hurling and football) under its jurisdiction during 2021.

NUMBER ALLOWED ENTRY TO GROUNDS/PITCH:

• Number of Players, Number of Officials, Pitch Access and Water and Hurley Carries, Pitch Access, Number of Officials allowed, Match Parking, Dressing Room Use will all be decided by Management Committee of the County Board, with the up-to-date GAA Covid advise and regulations. Clubs will be advised before games.

NOWLAN PARK MATCH DAY ARRANGEMENTS AND REGULATIONS:

- Parking, Dressing rooms, Pitch Access, Club Personnel in the Pitch Enclosure will be decided by Management Committee of the County Board with the up-to-date GAA Covid advise and regulations. Clubs will be advised before games.
- Smoking is prohibited in the Stand's and on the Pitch.
- Official Photographers are to be located behind the end-lines.
- In the event of inclement weather:
- Clubs will be asked to limit their puck around to 25 minutes. The warm up areas will be rotated and Clubs will be notified of the area on the day. A puck around will not be allowed at half time. Warm Up exercises involving Sharp Turning or Repetitive on the Spot routines that are likely to cut up the ground should be left out. Additional warmups if required can be arranged by the clubs at external venues.
- Substitutes: During the game, a maximum of three players may warm up on the side-line wearing tracksuit tops or bibs. The warmup takes place at the same end as the substitutes are seated, Hurleys and sliotars are not allowed as part of this warm up. All substitutes and temporary substitutions must be made through the 4th Official - Linesman at the halfway line by the Runaí or Nominated Person.
- Team Photographs: Photographs will be taken as the teams exit the Dressing Rooms. Players are asked to remove their helmets, tops, and line out in three rows with the goalkeeper in the centre of the front row and the substitutes standing on the bench at the rear.
- Videos: Permission is required from the County Secretary for the Videoing of all games.
- National Anthem - Parade: Where the National Anthem precedes a game, teams are asked to remove helmets and stand to attention facing the Tricolour in a respectful manner. When a Parade is organised, helmets must also be removed.
- Cathaoirleach: Games and Ground regulations apply to all players and officials and adherence to the regulations is the responsibility of the Club Chairman. In his absence it will pass to the Runaí/Nominated Person. The Bainisteoir also shares the responsibility of ensuring the Games Regulations are respected.
- Please leave the Dressing Rooms tidy and in a good condition after the Game.
- Dressing Room Access: Under Child Welfare and Protection Children (U17's) may not enter the Dressing Rooms.
- First Offence: Minimum €200 fine on club and letter of warning. Any Subsequent Offence: Double the fine each time within a calendar year.

DRESS CODE:

- For the concluding stages of all Championships, players are expected to wear consistent togs, socks, and jerseys. Also, jerseys to be numbered as per match programme.
- o First Offence: Minimum €200 fine on club and letter of warning.
- o Any Subsequent Offence: Double the fine each time within a calendar year.

CONDUCT OF PLAYERS/OFFICIALS:

1. Verbal abuse to match officials by players and/or team/club officials.
- First Offence: Minimum €200 fine on club and letter of warning. Individuals involved may receive a suspension.
- Any Subsequent Offence: Double the fine. Individuals involved may receive a suspension.
2. Unauthorized incursions on to the field of play (including Hurley carriers/team mentors around the side-line) thereby causing interference of any kind.
- First Offence: Minimum €200 fine on club and letter of warning.
- Any Subsequent Offence: Double the fine plus individuals involved may receive a suspension.
3. Any kind of physical interference by players and/or team officials/club officials.
- First Offence and Any Subsequent Offence: Rule Book to apply.

4. Any kind of physical interference by players and/or team officials/club officials. (Where the Referee does not report any individuals in his Report).

- First Offence: Minimum €500 fine on club and letter of warning.
- Any Subsequent Offence: Double the fine and consideration be given to excluding club from some competitions.

5. Any club responsible for terminating a game prematurely.

- First Offence: Loss of game and minimum €500 fine on club and letter of warning.
- Any Subsequent Offence: Double the fine and consideration be given to excluding club from some competitions.

6. All substitutes and officials must stay in dug outs during games except team manager, Maor Foirne, Hurley/water carriers, and medic.

- Minimum Fine: €200.

7. Teams must line up for official photograph before all Semi Finals and Finals.

- Minimum Fine: €200

(Teams are requested to form three rows for photographs please. Goalkeeper in the middle of front row with tracksuit tops, and in hurling games, helmets removed.)

8. Players must line out in accordance with numbers on the official programme.

- Minimum Fine: €200

REGISTRATION OF PLAYERS 2021

Rule 2.3

(A) A Club Registrar shall submit annually to Central Council, by the process of Electronic Registration, separate Registers in the Irish Language (except as provided for in Rule 1.7) of the Club's Adult, Under 21, Minor and Juvenile (all grades) players. A player is to be included in only one of the Registers. A copy of the Club's Registration shall be forwarded by e-mail by Central Council to the County Secretary, the Divisional Secretary, where applicable, and the County Minor and Juvenile Committees as appropriate.

This list shall include the full name, address and date of birth of each player.

(B) It is optional to have the addresses of Players registered in either Irish or English.

(C) Additional Registrations may be made subsequently.

- A Player must be registered at least three days before a game.

Note: Bord na nÓg 2nd Teams

• All Clubs entering a second team into a grade of competition must submit to the Bord na nÓg Registrar (registrarbng.kilkenny@gaa.ie and secretarybng.kilkenny@gaa.ie) a list of their first fifteen "A" players before League and championship competitions commence. The list submitted for the League does not have to be identical to the list submitted before the championship.

- These lists will be available to all clubs on request.

• The fifteen players named can be different for hurling and football and are not allowed to play in the second team. If a "B" team player plays in an "A" championship he is no longer eligible to play in the "B" championship but maintains his "B" league status.

• In an "A" League/ Championship competition a player playing in the knockout stage of the League will become ineligible to play for the "B" team. • "A" teams will play before "B" teams. Special consideration will be made to facilitate Clubs with three teams in a grade

• Note All Coiste na nÓg league Matches will be 15 a side. Exception. if one team can't field 15 players on the day of the game, both teams must play 13 a side. 7 substitutes can be used when available 13 a side. All Championship games are 15 a side.

FIXTURES RESPONSIBILITY:

• Plenary powers are devolved to the C.C.C. to deal with all matters relating to fixtures.

• The C.C.C.'s shall make all fixtures for Senior, Intermediate, Junior, Junior "A", Junior "B" Junior C , Junior D, Junior E and Junior F Under21, Under 19 and Juvenile Hurling and football competitions.

• The full fixtures list shall be circulated to all clubs who shall have reasonable time to consider same and where necessary be given an opportunity to seek a change of date or postponement.

• Official fixtures list for the year shall be ratified by An Coiste Chontae Chill Chainnigh.

• The C.C.C. reserves the right, dependent on progress by Kilkenny in the Inter-County Championships, to alter fixtures to facilitate the running of the local League and Championship competitions.

• Once fixtures are ratified by An Coiste Chontae Chill Chainnigh, only the Chairperson of the C.C.C. (in consultation with the Cathaoirleach of An

Choiste Chontae, if necessary) shall have the right to postpone or alter a fixture.

• The Chairman of Coiste na nÓg shall have the same authority for Coiste na nÓg fixtures.

• Where a postponement is granted in accordance with accepted conditions, the C.C.C. shall make the re-fixture.

MATCH CHANGES:

• Clubs can agree with the agreement of the CCC to bring forward Games provided they do not interfere with any other Fixtures

Note: Requests for minor changes to Fixtures will not be accepted after 10pm on the Sunday evening before the game.

POSTPONEMENTS:

• Games under the control of the C.C.C. may be postponed for a death in the immediate family circle (father, mother, brother, sister, child) of a player or the registered Chairman, Secretary or Treasurer of a club.

• A game due to have been played up to and including the day of the funeral may be postponed.

• Any other case in which a club feels it necessary to seek a postponement of a game due to a death shall be considered by the C.C.C. and judged on its merits.

- Senior, Intermediate and Junior Hurling League or Championship games postponed for any reason shall be played on the Tuesday evening following the original fixture date, under lights if necessary. Covid Regulation – League • Were the teams being unable to fulfil fixture due to covid the game be awarded to opponents Championship
- Covid Regulations for Championship will be decided by An Coiste Chontae Chill Chainnigh at a later date.

INTER COUNTY PLAYERS:

- Inter-County players of all grades may play for their clubs on the Sunday before Inter-County games except Leinster Finals, All-Ireland Quarter-Finals, Semi Finals and All-Ireland Finals and clubs may not be granted postponements for this reason.
- The County Board may permit any member of the Kilkenny County team panels to play in a club championship game.

LEAGUES AND CHAMPIONSHIPS:

FORMAT OF SENIOR / INTERMEDIATE HURLING LEAGUES 2021:

- Twelve teams drawn into two groups of six. The Groups of 6, Group A and Group B, the groups will then be sub divided into 2 group of 3, A1, A2, in Group A and B1, B2 in Group B, with the teams playing across A1 teams will A2 teams and B1 teams playing B2 teams, The top two teams in each group to qualify for the League and 2nd place teams will play in the Shield Finals with the draw as follows:
- League Final: Winner Group A v Winner Group B. (Finish on the Day).
- Shield Final: Runner-Up Group A v Runner-Up Group B. (Finish on the Day).

- 13 Teams – Open Draw to form 4 groups Group A, Group B, Group C, Group D. 4 Teams in Group A, 3 teams in Group B, C and D, In league Teams in Group A will play across teams in Group B and Teams in Group C will play across teams in Group D.
- 2 League Finals – Top team in Group A plays the top team in Group C, Top team in Group B will play top team in Group D

CHAMPIONSHIP:

Based on final League placing's

(1 Match) Preliminary Round (Draw to be done)

- 4 team in Group A v 3rd team in Group A/3rd team in Group C/3rd Team in Group D. (Finish on the Day)

6 Matches Round 1(Draws to be done and seeded to avoid repeat league championship fixtures)

- 1st Team in Group A v teams 3rd team in Group/Preliminary Round Winner (Finish on the Day)
- 1st Team in Group B v teams 3rd team in Group/Preliminary Round Winner (Finish on the Day)
- 1st Team in Group C v teams 3rd team in Group/Preliminary Round Winner (Finish on the Day)
- 1st Team in Group D v teams 3rd team in Group/Preliminary Round Winner (Finish on the Day)

- 2nd team in Group v 2nd team in Group (Finish on the Day)

- Six Round 1 winners in an open draw (Finish on the Day).

- 7 teams form one group. Each team play the other teams in the group. (Seven Rounds).
- League final - First placed team plays second placed team (Finish on the Day)

- The two Round 2 winners play Team 1 and Team 2 (Open Draw) (Finish on the Day)

Junior Section B Final

- The two Round 3 winners play, with the winner progressing to the County semi-final. (Finish on the Day)

- 10 teams, draw into 2 groups of 5, Group A and B, every team plays team in their Group, 5 Rounds,
- League Finals Winner of Group A v Winner of Group B. (Finish on the Day) • Note All league Matches in Junior C, D and E will be 15 a side. Exception. if one team can't field 15 players on the day of the game, both teams must play 13 a side. 7 substitutes can be used when available 13 a side. All Championship games are 15 a side.

- 9 teams draw into 2 groups Group A (5 teams) and Group B 4(4 teams) each team plays teams draw in same Group.
- League Final – 1st Team in Group A v 1st Team in Group B (Finish on the Day) • Note All league Matches in Junior C, D and E will be 15 a side. Exception. if one team can't field 15 players on the day of the game, both teams must play 13 a side. 7 substitutes can be used when available 13 a side. All Championship games are 15 a side.

CHAMPIONSHIP

1st Round

- 4 Matches 1 team a Bye (Finish on the Day)

2nd Round (Finish on the Day)

- 4 Matches -Best 1st Round winner gets bye to Semi Final

- (Match A) 2nd best 1st round winner v team with bye in 1st Round (Winning team get bye to Semi Finals)

- (Match B, Match C Match D)6 remaining teams drawn against each other seeded draw to avoid 1st round repeat fixtures. 3 losing teams eliminated

Quarter Finals (Finish on the day)

- 2 Matches - Loser of Match A in 2nd Round plus Winners of Match B, Winner of Match C, Winner of Match D.

- Losers of the 2 matches eliminated.

Semi Final (Finish on the day) 4 remaining teams

County Final (Finish on the day)

- Best Winner Criteria in Order (After Normal time 1st, Extra time and then finish on the day)

- (1) Highest Winning Margin
- (2) Highest Score by Winning team
- (3) Most Goals scored by Winning team

EXTRA TIME AND FINISH ON THE DAY REQUIREMENTS (Extra Time followed by Finish on the Day)

- All competitions Knockout League and Championship in Hurling and Football are finish on the Day.
- The following is the finish on the day procedure
- Two periods of ten minutes of Extra time will be played. If Still level Finish on the Day shall be applied.
- Winner on the Day Regulations.
 - o The relevant rules for shall apply in relation to Penalty Shootout.
 - o Penalties shall be taken for goals only
 - o Each team shall have five different penalty takers. (Goalkeeper can be a penalty taker too)
 - o Only players who are on the field of play at the end of extra time shall be allowed to be a penalty taker or goalkeeper.
 - o If Goalkeeper is injured during the penalty shootout, he may be replaced by substitute Goalkeeper.
 - o After both teams have taken 5 penalty kicks, the team with the most goals scored shall be declared the winner.
 - o If both teams are level after the 5 penalties, then sudden death format 1 penalty at a time to both teams shall be applied until one team has scored more than the other.
 - o The "Sudden Death" penalty takers must be drawn from original 5 players nominated for the start of the penalty shootout.

UNPLAYABLE PITCHES:

- If a home pitch is not playable, in the Senior, Intermediate, Junior Football League and Championships Senior Leagues Division 1, 2, and 3, the All County League Junior Hurling, Junior A, Junior B, Junior C and Junior D Junior E, Junior F the game will be played at the away team's pitch.

COLOURS CLASH:

- In the event of two club colours clashing both sides change colours. Minimum Fine: €200

PARENT RULE:

- Bye Law: Children living in Kilkenny City Parishes who do not make the panel (1st 25 players) for the O'Loughlin Gaels, Dicksboro or James Stephens number one team at Under 15 or 17 age groups may seek permission from the CCC to declare for their father's or mother's home club. On completion of the under seventeen grade the players shall then have the option to remain with their adopted club. Permission to be sought from the CCC committee before the 15th of February and adjudicated on by the County Board at the March meeting.

WALKOVERS:

- When a walk over is given on the day of a game the following fines shall apply: -
- All Adult Games - €100 fine. All Bord na nÓg Games - €50 fine.
- A team failing to play any of its League games - Maximum €1000 fine.
- A team failing to fulfil a championship fixture -Maximum €500 fine

CUPS and TROPHIES

- All Cups, Trophies, Shields are to be inscribed by the Winning Clubs and returned to the Vice Chairperson of the organizing Committee

MATCH CHARGES FOR 2021

- Match Day Charges for league games same as last year €5. Match day Charges for Championship will be decided by An Coiste Chontae Chill Chainnigh later date.

REFEREE'S EXPENSES

- Adult Games: €40
- Bord na nÓg games: €40
- Referee acting as side-line official: €25
- In Adult & Coiste na nÓg League & Championship Games the home side pays the referee.
- Referees are to be paid before commencement of Matches

Cover can be extended to Clubs under the GAA Property and Liability insurance programme once the following requirements have been met:

Approval to hold such a camp must be applied for and granted by Kilkenny County Board.

- 1 Approval will only be granted where the club holding the camp has in place a system to adhere to all recommended Best Practice Guidelines and only where suitably qualified persons are permitted to run these camps.
- 2 Where the camp is being run by individuals for profit, these persons must produce evidence of their own Public and Professional Indemnity Insurance and a code of best practice document.

This code of best practice must include as a minimum but is not limited to;

- minimum qualifications to be held by persons involved in the camp
- procedure for vetting of persons engaged in running the camp
- age of participants and supervisory ratios for the camp
- activities to be covered by the camp

A Template and Checklist and accident reporting forms are available from County Secretary Conor Denieffe or the office in Nowlan Park or they can be downloaded from the Resource section on the Kilkenny GAA website. **If an injury occurs at the camp, it must be notified as soon as possible with as much detail as possible (include pictures of the accident location if you can) and submit using the accident report form.** This will allow the club to record all details of the event in one location and this can really assist in investigating a claim especially if it is not reported to the club until after a number of months have elapsed.

COISTE CHONTAE CHILL CHAINNIGH CLG BYE-LAWS 2020

CONSTITUTION

The County Committee shall be called Coiste Chontae Chill Chainnigh Cumann Lúthchleas Gael. (Kilkenny County Committee GAA)

In accordance with Rule 3.11, T.O. 2020 the County Convention shall elect the following: Chairperson, Vice- Chairperson, Secretary, Treasurer, Coaching Officer, Public Relations Officer, Officer for the Irish Language & Culture. It shall also elect two representatives on the Leinster Council, one representative on the Central Council and shall appoint a Children's Officer and Development Officer, recommended by the outgoing County Committee.

The office of Treasurer, subject to Annual Election, is not subject to a limitation in years of service (Rule 3.11, (b) Exception 2 Official Guide 2020).

Kilkenny GAA County Committee shall be composed of the following who shall have voting rights:

- Chairperson.
- Vice-Chairperson.
- The Chairperson of the Football Sub Committee.
- The Chairperson of the Junior Board Sub Committee.
- Secretary.
- Treasurer.
- One Central Council Representative.
- Two Leinster Council Representatives.
- Development Officer.
- Coaching Officer.
- Public Relations Officer.
- Children's Officer.
- Officer for Irish Language and Culture.
- One named representative from each affiliated adult club competing in the current championships at Junior Intermediate or Senior Grades.
- The Secretary of the Junior Board –Sub-Committee.
- One named representative from Coiste na nÓg Sub-Committee.
- One named representative from Cumann na mBunscoileanna.
- One named representative from the Kilkenny County Handball Committee.
- One named representative from the Kilkenny Post Primary Schools Committee.
- County Referee's Administrator.

In accordance with Rule 3.20, T.O. 2020 the County Committee at its first meeting after County Convention shall appoint the following Sub-Committees membership of which shall be as set out in these Bye-Laws. All members of sub-committees shall be named.

MANAGEMENT COMMITTEE:

It shall consist of:

- Chairperson of Kilkenny County Committee.
- Vice-Chairperson of Kilkenny County Committee.
- Secretary of Kilkenny County Committee.
- Treasurer of Kilkenny County Committee.
- Central Council Representative.
- Two Leinster Council Representatives.
- County Committee P.R.O.
- Four representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.
- Outgoing County Chairperson for one year after stepping down from the position.
- Chairperson may from time to time select personnel (who shall be Members of the Association) with expertise in specific areas if

required (without voting rights) for appointment by the County Committee. These selected personnel shall only attend and advise when their areas of expertise is being discussed.

COMPETITIONS CONTROL COMMITTEE:

It shall consist of:

- Chairperson who shall be the Vice-Chairperson of Coiste Chontae Chill Chainnigh.
- Chairperson of Kilkenny County Committee.
- Secretary of Kilkenny County Committee.
- One representative from the Junior Committee.
- One representative from the Football Committee.
- One representative from Coiste na nÓg.
- County Referee's Administrator (who shall vote only on the appointment of referees)
- One Fixtures' Analyst
- Four representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.

FIXTURES ANALYSTS:

Two Fixtures Analysts shall be appointed by the Management Committee who shall act in accordance with R 3.20 (iii) of T.O. 2020.

COUNTY HEARINGS COMMITTEE:

This committee will be appointed by the County Committee. It will consist of seven members who do not all have to be members of the County Committee and must not be current members of the Management and Competitions Control Committees.

CCC COUNTY PLANNING, PHYSICAL DEVELOPMENT AND SAFETY COMMITTEE:

It shall consist of the following:

- The Chairperson who shall be the County Development Officer.
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- Safety Officer.
- Two named representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.

*OPTIONAL –

The Chairperson of Kilkenny County Committee with the approval of the County Committee shall nominate four individuals with appropriate expertise each year and these shall be subject to appointment by the County Committee.

COUNTY COACHING AND GAMES DEVELOPMENT COMMITTEE:

The members of this Committee will be the following:-

- The Chairperson who shall be the County Coaching Officer.
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- Vice Chairperson of Kilkenny County Committee.
- The County Games Development Manager (who shall be secretary of this Committee).
- Two named representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.

*OPTIONAL –

The Chairperson of Kilkenny County Committee with the approval of the County Committee shall nominate 4 named individuals, non-County Committee members, to the Coaching and Games Development Committee each year and these shall be subject to appointment by the County Committee.

COUNTY CULTURAL COMMITTEE:

The members of this Committee will be the following:

- Chairperson who will be officer for Irish Language and Culture.
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- Four Representatives from County Committee who shall be elected by ballot at the first meeting of the County Committee following County Convention.

*OPTIONAL –

The Chairperson of Kilkenny County Committee with the approval of the County Committee shall nominate two individuals with appropriate expertise each year and these shall be subject to appointment by the County Committee.

COUNTY PUBLIC RELATIONS/MARKETING & INFORMATION TECHNOLOGY

COMMITTEE:

The members of this Committee will be the following:-

- The Chairperson (County Committee PRO).
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- The Vice-Chairperson of Kilkenny County Committee.
- The County IT Officer.
- Two representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.

*OPTIONAL –

The Chairperson of Kilkenny County Committee shall with the approval of the County Committee nominate four individuals each year and these will be subject to appointment by the County Committee.

COUNTY YOUTH COMMITTEE:

The members of this Committee will be the following:-

- The Chairperson –
County Children's Officer.
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- The Vice Chairperson of Kilkenny County Committee.
- The representative on the County Committee from the following:-
 - Cumann na mBunscoileanna.
 - Coiste na nÓg Sub- Committee
 - Kilkenny Handball Committee.
 - One representative from the Post-Primary Schools.
- Two representatives from the County Committee who shall be elected by ballot at the first meeting following County Convention.

COUNTY REFEREES ADMINISTRATION COMMITTEE:

The nine members of this committee shall be the following:-

- The Chairperson –
County Referees Administrator.
- The Chairperson of Kilkenny County Committee.
- The Secretary of Kilkenny County Committee.
- Two County Tutors (trained).
- Four other members who shall be nominated by County Chairperson for appointment by County Committee.

COUNTY FINANCE COMMITTEE:

The County Finance Committee shall be a Sub-Committee incorporated in the County Management Committee to deal specifically with financial matters.

This Sub-Committee shall consist of the following:

- Chairperson of the County Committee.
- Vice Chairperson of the County Committee.
- Secretary of the County Committee.
- Treasurer of the County Committee.
- One suitable member who shall be nominated by the Chairperson for appointment by the County Committee.

A recommendation of the County Management Committee on a matter of finance may not be upset save by a two thirds majority of the members of the County Committee present, entitled to vote and voting.

COUNTY TEAMS MANAGEMENT AND PANELS SUBCOMMITTEE:

Membership of which shall be in accordance with the Charter of the Co. Committee R. 3.20 (xiii), T.O. 2020.

HEALTH AND WELLBEING COMMITTEE:

This Committee will comprise of six members, with relevant expertise, nominated the Chairperson for appointment by the County Committee.

TRANSFERS AND REGRADING:

1. Applications for Transfers shall be made to the Rúnaí of the County Board on the official form as approved by the County Committee before January 31st and shall be processed in accordance with Rial 6.5 T.O 2020.
2. The C.C.C. shall process and make decisions on all applications for Transfer.
3. Transfers within the county shall be granted only in the event of a player moving to a new place of Permanent Residence which is within the Parish of the club to which he wishes to transfer. In such cases the onus of proof of new permanent residence shall be on the applicant for transfer. For the purposes of these Bye-Laws the CCC in assessing the question considers his permanent residence to have been for at least the previous twelve consecutive weeks and is likely to remain so for at least the ensuing 12 months.
4. A player seeking to transfer from one club within the County to another club within the County may submit supporting documentation, together with his completed transfer application form. The CCC will assess the application based on all the information before them.
5. In considering the authenticity of a claim to permanent residence in a specific area the CCC may require the submission by the player of documentary proof of such permanent residence in the form of Utility Bills, Bank Statements, correspondence from the Office of the Revenue Commissioners, extract from the current Register of Electors etc.
6. For a player under eighteen years of age, residence shall be deemed to be that of the 'permanent residence' of his family. In the event of the parent(s)/guardian(s) of a player under eighteen years of age not living at the same address, the matter of permanent residence shall be determined by the CCC based on the information available to them.

All requests for Regrading shall be made on the appropriate form and submitted to An Rúnaí, County Committee no later than January 31st each year.

Football:

All requests for Regrading shall be made on appropriate form and submitted to An Rúnaí, County Committee no later than January 10th each year.

All requests seeking permission to play with another club shall be made on the appropriate form and submitted to An Rúnaí, County Committee no later than January 10th each year. Final decision of which club a player plays with rests with the County Board.

Grading:

Grading/Regrading shall be in accordance with Rule 6.20 T.

- (i) The County CCC Committee shall decide on all applications for re-grading of players.
- (ii) A Club may only apply to have players regraded by one level, other than where a club has been relegated from a championship in the previous year.
- (iii) A player's status is determined by the last championship match he played in.
- (iv) Playing in a Relegation Final does not affect a player's status.

(v) That a maximum of two players who played on the winning team in the previous year's Senior, Intermediate & Junior Championship County Finals may apply for regrading.

DIVISIONAL COMMITTEES, SUB-COMMITTEES AND CLUBS:

In accordance with Rule 3.19(l) T.O.2020 the County Committee shall appoint the following Sub – Committees:

Junior Committee:

The Junior Committee officers shall be the Chairperson, Vice-Chairperson and Secretary, Treasurer and PRO appointed by the County Committee and shall consist of one representative from each affiliated adult club competing in the current championships.

The Junior Committee shall be entrusted with the running of the Junior A, B, C and D Championships and Under 19 and Under 21 Hurling Championships – The Competitions Control Committee of County Committee will have full control over both these committees (the Junior and Bord na nÓg Committees) and reserves the right to run the Senior, Intermediate and Junior Hurling Championships in the County.

Summary reports from the Junior Committee, Coiste na nÓg, and Cumann na mBunscoileanna, including Disciplinary Reports, shall be submitted by the relevant committee Runai after each meeting to the Secretary County Committee for the information of County Committee within five days of the meeting.

The Junior Committee, Coiste na nÓg, Cumann na mBunscoileanna, Post Primary Committee and Handball Board, are each obliged to elect a Competitions Control Committee with the same functions within the Committee's jurisdiction, as those of the Competitions Control Committee at County Level. Appeals and requests for a Hearing from Junior Committee and other Committees shall be heard by the County Hearings Committee.

Football Committee:

The Football Committee shall consist of three officers and shall be appointed by the County Committee.

Coiste na nÓg Committee:

The Coiste na nÓg Sub Committee shall consist of two representatives from each affiliated club competing in its current championships. Six officers of Coiste na nÓg shall be appointed by County Committee.

Post Primary Schools Committee:

The county Post Primary Schools Committee shall be a sub-committee of the County Committee and membership must include a representative of each affiliated post primary school, a representative of the County Coaching & Games Development Committee, a representative of Coiste na nÓg. The Cathaoirleach of the committee shall be nominated by the Cathaoirleach of Coiste Chontae of the day and is subject to the time limit of the terms of office.

The Committee shall elect officers as required plus a representative to the County Committee and the County Coaching & Games Development Committee.

COUNTY BOUNDARIES:

The Kilkenny County Boundary at present (January 25th 2016) used for G.A.A. purposes shall continue to be recognised despite any future changes in the Local Government administrative boundary or unless otherwise determined by Provincial or Central Council.

ATTACHMENT TO FIRST CLUB – RULE 6.4 T.O. 2020:

A person seeking to become a Member of the Association shall be restricted to joining the Club in the catchment area of his permanent residence as determined by the County Committee at their meeting on January 25th 2016 (Parish Rule applying).

PARENT RULE:

Children living in Kilkenny City Parishes who do not make the panel (1st 25 players) for the O'Loughlin Gaels, Dicksboro or James Stephens number one team at Under 15 or 17 age groups may seek permission from the CCC to declare for their father's or mother's home club. On completion of the under seventeen grade the players shall then have the option to remain with their adopted club. Permission to be sought from the CCC committee before the 15th of February and adjudicated on by the County Board at the March meeting.
